2. Stays informed about committee matters, is prepared for meetings, and reviews and comments on minutes and reports.
3. Builds a collegial working relationship with other committee members that contributes to consensus-building.
4. Participates in the board's organization-level evaluation and planning efforts. Also participates in board self-evaluation and planning process.
5. Participates in the advancement of our mission and strategic plan including fundraising and member recruitment.
