Tree Davis draws upon the strength of community and science to improve our neighborhoods, area cities, and surrounding natural areas by planting trees. We are making our environment healthier and more resilient. Established by civic leaders in 1992, Tree Davis has had many accomplishments that profoundly impact Davis, West Sacramento, Winters, and Woodland. As the impacts of climate change become clearer, the importance of a vibrant urban and community forest to mitigate against increased temperatures, air pollution, and water contamination, and its capacity to enhance biodiversity is ever more critical. In 2024, Tree Davis planted over 260 trees, provided care and stewardship by watering them over 2,000 times, pruned over 940 trees to ensure proper growth, and mulched and weeded over 900 times. Tree Davis also maintained climate-ready demonstration landscapes of drought-tolerant plants that lower watering needs in public spaces and illustrate sustainable gardening practices. We value these important public outreach and education initiatives in N Street Park and the Tree Memorial Grove.

Through our Climate Ready Education program and our other educational outreach, we have engaged over 550 high school students, demonstrated the value of trees and the need for sustainability in urban green spaces, and showed students career pathways in urban forestry. In 2024 Tree Davis partnered with Texas Trees Foundation and Woodland Tree Foundation to begin work at 9 schools in Washington Unified School District and Woodland Joint Unified School District, launching a significant local school greening program—Cool Schools Yolo.
